Whitecotton who received a deed for the same from Etna Lefforge and Dola Lefforge, his wife, on September 21, 1944; that said deed fails to furnish a means by which said land can be located with reasonable certainty, and the deed by which his grantors received title thereto is equally vague; that earlier conveyances do not supply better evidence of the location; that during field surveys conducted by me in 1951 and in 1976 for John P. Whitecotton I endeavored unsuccessfully to discover the whereabouts of the real estate; that John P. Whitecotton has never known where to find the property and has never had possession of it; and that the Plat Book for the Amo Corporation places the land near the south line of the quarter section, but that site consists only of unbounded property occupied and used by the Penn Central Railroad as operating right of way.

I further certify that it is my opinion that a mistake has been perpetuated by a chain of deeds which purported to convey a parcel of land which never existed per se, and which does not now exist. Therefore, I recommend that said key number and other data associated with it be stricken from the records of taxable lands in Hendricks County in a way that will not exempt the Penn Central Railroad from assessment of its distributable property.
