(d) For failure to perform his duties or for any violation of any of the provisions of this act or of chapter 2 of the Acts of the special session of the General Assembly of 1865 or of chapter 38 of the Acts of the regular session of the General Assembly of 1877 such assessor shall be subject to the penalties precribed in chapter 2 of the Act of the special session of 1865. 
