S. 36 and had just negotiated a slight left hand curve when the driver lost control of the veh. and began sliding on ice on the roadway. The car apparently spun around and crossed the roadway leaving the road 198ft. south of the curve. In chair next to the table was a handmade leather belt hearing the name "Laura" engraved in it. (8-9-10) Herbert C. Bobb Jr., age 25, David & Dana Friedman24 In July13, 1981 at 1835 hrs., this officer was advised of a affic accident involving fatalities on SR 267 400ft, s of CR /50E. Upon my arrival, I observed the burned body of Herbert C. Bobb Jr. inside the burned remains of a 1979 vellow Dodge tk. Also, sitting behind the sheel of a 1979 blue Olds cutlass station wagon was the deceased driver David Lee Friedman. A female passenger in the Olds, Dana S. Friedman, was transported to Methodist Hospital via lifeline Helicopter with severe head injuries. She later died on July 14, 1981 at 1700 hrs of said injuries. Investigation disclosed that the Olds had been n/b on SR 267 and had just entered the curve when it was struck head on by the Dodge tk which was s/b in the n/b lane. Skid marks at the scene indicate that the Olds skidded approx 20ft prior to impact. After impact, the vehicles traveled approx 25' in a n/b direction before coming to rest in the n/b lane After coming to rest, the Dodge caught on fire, burning the engine and passenger compartments. The fire was a result of gasoline from broken fuel lines and the carburetor igniting against the hot engine. Passersby and the witness attempted to pull the driver of the Dodge from the wreckage without success. Subjects also attempted to throw dirt on the fire in an attempt t extinguish it. Partial reconstruction of the accident ind cates the following: The n/b Olds left front tire was 6ft

inside the vellow line of its own lane at the time of impact from the s/b Dodge tk. Upon measuring the collision overlap of the two vehicles which was 4ft and comparing that with the known position of the Olds at the moment of impact, this places the left front tire of the striking Dodge tk a full 10ft across the double yellow line at the time of impact. A witness to the crash, John A. Carson, advised that he had been no on SR 267 behind the Olds Cutlass wagon for approx 2-3 miles and they had been travelling approx 40-45MPH when the Olds started to enter the curve at the accident location. At that time, the Dodge appeared s/b at approx 70MPH in the wrong lane striking the Olds head-on. Mr. Carson also stated that the driver of the Olds had no time to take evasive action. After impact, the witnesses car was struck by flying debris from the tk. This investigator was later approached by James Riddle of 7647 S SR 267 Bburg, who advised he had observed the Dodge tk a few minutes prior to the accident s/b on SR267 in Fayette at an extreme rate of speed. Although blood sample results are not completed at this time it is the belief of this investigator that the Dodge as unable to negotiate the curve due to its high rate of speed ausing it to cross the center line and strike the Friedman

Driver #1 stated that he was operating a 1976 Ford F150 truck eastbound on TUDOR Road at approximately 45-50 MPH. As he approached the entrance to the Mud Creek bridge near CR 3000W he advised that a westbound motorcycle suddenly appeared and he struck it before he could take evasive action. Driver #1 related that at the time of impact he was on his side of the road and that the westbound cycle was in the center of the road or slightly left of center. Witness #1 advised that immediately prior to the crash he had observed the westbound cycle go by his house. The witness stated that he did not notice any excessive speed on the part of the motorcycle.

Investigation of the scene by this officer indicates that the Ford truck was eastbound of Tudor Road approaching the elevated bridge at Mud Creek which partially obscures drivers from seeing oncoming traffic as they enter the bridge. After impact skid and rolling tire yaw marks when compared to the 14 inch overlap impacy on the truck from the motorcycle places the Ford truck's left front itre at maximum engagement as 11 ft. north of the south edge of Tudor Road. This places the left front tire approximately 2 ft north of the center of the road.

After placing the Ford truck in the roadway in relation to the tire marks in the road at impact (with the front wheel of the motorcycle still embedded in the front bumper of the truck 14 inches inside the left bumperedge,) places the motorcycle 8 ft6in.— 9ft from the north edge of the 18 ft. wide road at maximum engagement.

In summary, from the evidence on the roadway and the vehicles involved, this investigator concludes that at the time of impact the left fromt tire of the westbound truck was 2 ft. left of center and the eastbound cycle was in the approximate center of the road. This officer could find no evidence from physical evidence or witness and driver statements that any pre-impact evasive action was taken by either driver.

Holloway, who was a witness to the accident. The dispatcher responded 2 units and an ambulance and the Danville fire department for rescue. UPon the arrival on the scene of the first unit, Deputy Ray Wright Unit 460 he advised that the driver was trapped in the vehicle and the Emergency Medical Technician on the scene, Alonzo Lagle advised that the victim had suffered fatal injuries to the head. Upon the arrival on the scene of this officer at 8:16 pm the accident scene was secured, and the Hendricks county coroner was notified. Ther were 3 witnesses present at the scene of the accident who gave this officer written statements as to what they had observed. From the reports given this officer it appeared that the driver of vehicle-1 who had been traveling westbound on road 36 had passed vehicleW-l and was just ahead of vheicle W-l when the driver apparently felt he couldn't successfully pass, backed off and swerved back into his lane.

After the truck pulled back into his lane the first of the 2 was witness W-1. Witness W-2 then stated that he looked in his rearview mirror, and when he looked forward again the driver of Vehicle #1 was veering his vehicle to the right and the vehicle then proceeded into the culvert and flipped over and skidded on its top in the ditch. Witness #W-2 then stated that as far as he could determine there was no reason for the drivers actions. Vehiclel had skid marks of 160.6 feet from first braking to impact location on the left wheel, and skid marks of 104.1 feet from first braking to impact location of the right wheel. Vehicle was resting on its top, and photographs were taken at the scene and mortuary. Blood alcohol test was taken at mortuary by Hendricks county coroner, and was forward to Dept. of Toxicology for results. Vehicle was impounded and sent to Holloways impound lot Plainfield. Notification was made to relatives by the Parke county sheriff department. In as far as this officer can determine from witnessess statements the Transport International Pool truck had plenty of time to pass and was not a factor in the accident. No other persons were present at the accident as witnesses. Contributing circumstances to the accident may have been the drivers speed, as witness W-1 stated that they were traveling 50 to 55 miles per hour, and that driver #1 attempted to pass them and accelerated past the speed limit. Also the odor of alcohol on the driver of Vehicle #1 may have been a contributing factor.

Wynn also taken to Hendricks County with head & back injuries along with a possible fracture of the back. Mr. Thomas Milton Taylor was pronounced dead at the scene by Hendricks County Corner Steve Mattews. Through investigation it was learned that Mr. Taylor died of a broken neck.

Through investigations and statements given by a witness who s stated just prior to the accident he observed the vehicle

traveling at a high rate of speed & neraly lost control of the vehicle at the intersection of state raod 236 and county road 200 N. Mr. Danny R. Pittcock stated that himself and his two passengers were northbound on state road 236 north of county road 350 N when a Opossum or Cat ran in front of his vehicle. Mr. Pitcock stated that he swerved his vehicle to the right at which time the edge of the roadway grabbed his tire forceing him to correct his vehicle by steering left which threw his vehicle out of control causing it to leave the roadway knocking down a sign and rolling the vehicle. It is not believed that this accident was caused by an alcoholic beverage or drug.

#8 11-6-82 Justice On November 6, 1982 at 1:52 am. this officer was contacted in regards to a traffic fatality on US 36 east of CR 900E. Upon my arrival I observed the body of the victim, Jerry Justice, lying in the roadway with his head facing north and feet south. Also at the scene was a brown 78 Chevrolet truck parked inthe roadway east of the victim. The front of the vehicle had fresh damage to the grill and hood along with what appeared to be blood. It was determined that this was the striking vehicle. Upon speaking with the driver of the turck, Scott Hardwick he advised he had been operating the truck westbound on US 36 in the slow lane at or below the speed limit. A vehicle had just passed him in the passing lane when he observed the victim standing in the road. Driver attempted to avoid collision but was unable to do so. After impact, the driver moved the truck to the east of the victim to prevent other traffic from striking it. Investigation and partial reconstruction of the accident indicate the following: The impact on the striking vehicle was 1 ft. 11 in. from the right edge of the front bumper. Found at the scene, in addition to a blood trail from the victim, was a scrub mark in the pavement made by the victim's blue jeans as they were pushed against the pavement. It is this investigator's belief the the beginning of the blue jean scrub mark was approximately 14 ft. west of the initial impact point as determined by paint chips found on the pedestrian at the time of the impact. This evidence as well as the blood trails left by the victim after the impact and also the position of afterimpact skid marks from the turck indicate that the truck indicate that the turck was operating totally in the the slow lane of westbound US 36 at the time

of impact and the pedestrian was approximately 4 ft. inside the travel portion of the westboundlane when he was struck. As for per-impact speped estimateions, as de determined from the vehicle's skid marks and reaction ime form point of impact to point where brakes were locked, indicate that the vehcile was travelling at or below the posted 50 m.p.h. speed limit prior to impact. Once impact was made, it took the driver approximately 1/3 second to get the brakes locked, which is a normal reaction time for an unimpaired driver. As to why there was no apparent pre-impact evasive action, the driver stated that his attention was momentarily distracted by another vehicl which was passing also westbound. In addition the victim was wearing dark clothing, that being blue jeans and a blue jean jacket. It was determined that the reason the victim was walking was due to the fact that his vehicle ha had ran out of gas and was sitting facing westbound on US 36 approximately ½ mile east of the accident scene. Shortly before the accident, the victim had purchased one dollar worth of gasoline at the Avon Super-Seven Store Apparently he was walking west to obtain assistance for his stranded vehicle. At this time, it is unknown why the pedestrian was walking in the travel portion of the roadway. Drug and alcohol screens were done on the victim, but as of the time of this report no results were back.

Investigation reveals the vehicle a 1971 green, Ford bearing 1982 INdiana plate 32L772, was eastbound on C.R. 100 East of C.R. 900 East when the right side tires left the roadway for some unknown reason at which time the driver apparently over corrected. Vehicle swerved to the northside of the roadway striking a utility pole trapping the driver David L. Smith Sr. who was the passenger. The investigation showed the passengers legs were pinned under the dash of the vehicle, the drivers legs were wrapped around the steering wheel confirming our findings that the son was driving. David A. Smith Jr. was transported by lifeline helicopter to Methodist hospital, with faial lacerations, in shock, with a possible fractured pelvis. The passenger David L. Smith Sr. was pronounced dead at the scene. Speed estimates show the vehicle was traveling at a minimum of 50 miles per hour. In a posted speed limit of 40 miles per hour prior to the accident.

March 9, 1983 Driver #1 William W. Dodd, age 27, 42 Esther ct. Plainfield, Ind. driving a '78 Toyota 2 door Corolla.

Driver #2 GAry, Major L., age 61, 42 Esther ct. Plainfield, Ind. driving a '74 Ford Van. Driver of vehicle #2 stated the only thing he could remember about the accident is seeing the Toyota cross over the center lane into his lane and hit the front of his van.

This officer believes that if the roads would have been in a safe condition without the snow and ice on the bridge this accident would not have taken place. At the time this officer was at the accident scene the bridge was a sheet of ice. At this time this officer cannot determine if there was any speed violations. It is to this officers impression that vehicle #1 slid on the bridge sideways into the front of vehicle #2.

Indianapolis, Ind. 46217, driving a '73 Buick' Electra 4 dr. Driver # 2 Glen E. Randolph, age 40, 42 B Port a-Call Drive, Indianapolis, Ind., driving a '73 Olds, 98 4 dr. Both driver #1 and Driver #2 were dead upon my arrival. Witness #1 states that vehicle #1 crossed the center line, veh. #2 tried to move out of vehicle # 1's path but could not do so. Witness #2 states that he felt witness # 1 move his vehicle to the right and then observed vehicle #1 striking vehicle #2 on vehicle #2 side of the roadway. From skid marks left by vehicle #2 he did skid in an attempt to avoid collision. I could not locate any markings on the road to indicate any evasive action by vehicle #1. Coroner will perform an autopsy on

driver #1 to determine if he possible could have been unconscious at the time he crossed the

center line and struck vehicle #2. Both bodies

The driver also states that he was going to swerve in the other direction however there was a child on a bicycle on the other side of the road also. The passenger in vehicle #1 states the same as the driver Both state that the bicyclist rode across SR 267 without paying attention to oncoming traffic, and did not allow vehicle #1 ample time to avoid collision Witness #1 states that the bicyclist did not appear to even look for oncoming traffice and darted out right in front of vehicle #1.
