


## CHARLES HUFFORD TO JAY HUFFORD


A part of the West Half of the Northwest Quarter of Section 21, Township 16 North, Range 1 East, Hendricks County, Indiana, described as follows: Beginning on the south line of said half-quarter section North 89 degrees 06 minutes 11 seconds East (assumed bearing) 680.26 feet from the southwest corner of said half-quarter section; thence North 0 degrees 10 minutes 19 seconds West parallel with the east line of said half-quarter section 1,117.01 feet; thence North 89 degrees 06 minutes 11 seconds East parallel with the south line of said half-quarter section 312.00 feet; thence South 0 degrees 10 minutes 19 seconds East parallel with the east line of said half-quarter section; thence South 89 degrees 06 minutes 11 seconds West along said south line 312.00 feet to the point of beginning; containing 8.000 acres, more or less. Subject to all legal highways, rights of way, and easements.

Purpose - The purpose of this survey was to divide a 20 acre tract, of even width, off of the east end of a specified tract.

The description of said 20 acre tract, as shown on the attached drawing, is as follows:

A part of the northwest quarter of Section 21, Township 16 North, Range 1 East, situated in Lincoln Township, Hendricks County, Indiana; and being more particularly described, as follows, to wit:

From the southwest corner of the aforesaid northwest quarter, proceed thence North 89°06'11" East (the bearing computed from a solar observation) along the quarter section line, 992.26 feet to the point of beginning. From said point of beginning, proceed thence North 0°10'19" West, 2,673.80 feet; thence North 89°09'46' East, along the section line, 325.87 feet; thence South 0°10'19" East, along the quarter-quarter section line, 2,673.46 feet; thence South 89°06'11" West, along the quarter section line, 325.88 feet to the point of beginning, containing 20.0000 Acres, more or less; subject to an easement for a county highway on and along the entire southernmost boundary, and also subject to the rights of the public for drainage along an existing creek, running diagonally across the southern portion of said tract. All dimensions computed from electronic measurements.

Note #1 - The center of the section is well defined, monumented, and has apparently remained established in its present location for many years, therefore, the location of the center of the section was accepted as correct without confirming it's accuracy by intersecting lines from opposite quarter-section corners.
