Mr. and Mrs. Richard Redmond asked me to survey and stake the frontcorners of their lot 1.8 miles north of Avon on S.R. 267, and to send my bill to you for forwarding to them.

The work is done and my bill is enclosed herewith. Pipe stakes were set with pink ribbons tied to them. They are protruding above ground and I recommend that they not be driven down any further as there is a buried telephone cable in the vicinity. But being up as they are there is a chance that mowers will hit them in the spring or summer.

I'm sorry that this job was delayed but the January weather made working impossible. Also, traffic on S.R. 267 greatly impeded the work and made it take a lot longer than it should have taken.

Please convey this information to Mr. and Mrs. Redmond with my apologies for not doing the job sooner. Also please tell them that the realtor's sign is down. I leaned it up against the post but I didn't have the hardware necessary to hang it properly.





RIGHT OF WAY GRANT Recorded December 7, 1908 Miscl. Record 8, page 113 Hendricks County Records.

This agreement witnesseth; That William Merritt and Abigail Merritt, his wife of Hendricks County, Indiana, in consideration of One dollars, the receipt of which is hereby acknowledged, do hereby grant and convey to the Danville Light Heat and Power Company the right and privilege to erect, maintain operate repair and renew poles guy stubs and wires for the transmission of electric current across and over the real estate in Hendricks County, Indiana, described as follows, to-wit:

Across the entire West side of the following described real estate: A part of the West half of the North West quarter of Section 35, Township 16 North, Range 1 East and described as follows, to-wit: Beginning at the Northeast corner of said half quarter and running thence South 23 chains and 52.6 links; thence West 20 chains to the Section line; thence North along the Section line to a point 16 rods South of the North West corner of said Section 35; thence East 40 rods; thence North 16 rods to the Section line, and thence East 40 rods and to the place of beginning.

Such poles are to be located as near the East side of the Avon and Brownsburg public road as is practicable so as not to interfere with any roads or passageways; and the wires shall be installed in a good, workmanlike manner and maintained in good and sound condition.

## NO.25.

By an assignment dated June 25, 1918 and recorded June 27, 1918 in Miscl. Record 11, pages 449-50, Hendricks County Records, the Danville Light, Heat & Power Co. assigned its right, title and interest in the above right of way grant (together with other grants) to the Merchants Heat & Light Co.

Under date of April 23, 1927, Merchants Heat & Light Company assigned to Indiana Electric Corporation, all of its property, including privileges and easements, said assignment appearing of record in Miscl. Record 16, page 234.

In Miscl. Record 19, page 51, appears an agreement of merger between Indiana Electric Corporation and Public Service Company of Indiana wherein the surviving corporation is set out as Public Service Company of Indiana. Recorded Feb. 11, 1932.

On January 26, 1951, the Public Service Company of Indiana was consolidated with several other Service and Power Companies of Indiana under the name of Public Service Company of Indiana, Inc. Miscl. Record 31, page 138.
