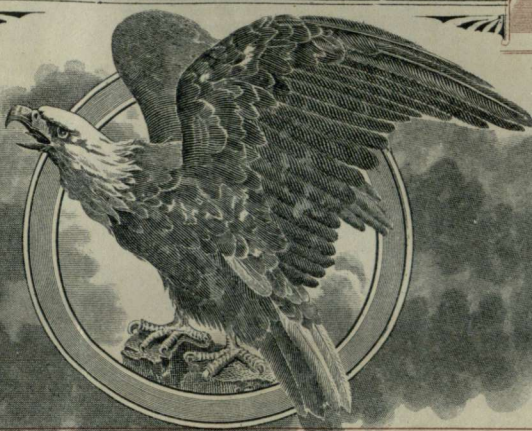

COURT HOUSE BOND

On January 15th 1928, the County of Hendricks, in the State of Indiana, for value received, will pay to the bearer, at the Office of the County Treasurer in the Town of Danville, Indiana,

FIVE HUNDRED DOLLARS

with

interest thereon at the rate of four per cent per annum, payable semi-annually on the 15th day of January and the 15th day of July of each year, at the Office of the County Treasurer in the Town of Danville, Indiana, on the presentation and surrender of this bond and the coupons thereto attached as they respectively mature.

This bond is one of Four hundred and fifty bonds of Five hundred dollars each, of like date consisting of ten series of forty five bonds each, each series being numbered from one to forty five, aggregating Two hundred and twenty five thousand dollars, issued under and by virtue of an Ordinance of the Hendricks County Council of Hendricks County, Indiana, passed at a special session, held on the second and third days of February, 1912, and by an order of the Board of Commissioners of Hendricks County, Indiana, at its regular session, held on the second day of April, 1912, in compliance with the laws of the State of Indiana, made and provided under an Act of the General Assembly of the State of Indiana, entitled "An Act Concerning County Business" and approved March 3rd 1899.

The first series of Twenty two thousand five hundred dollars shall become due and payable on January 15th 1923, with a series of Twenty two thousand five hundred dollars becoming due and payable on each succeeding 15th day of January, up to and including January 15th 1932.

Said bonds are issued by the Board of Commissioners of Hendricks County, Indiana, for the payment of the cost of building and equipping a new Court House, in Danville, Hendricks County, Indiana. It is hereby certified that all acts, conditions and things required to be done, precedent to and in the issuing of this bond have been properly done and performed, in regular and due form as required by law, and the total indebtedness of said County including this bond does not exceed any statutory or constitutional limitation of the State of Indiana.

In Witness Whereof, the Board of Commissioners of the County of Hendricks, in the State of Indiana, have signed this Bond and caused the Seal of the County to be hereunto affixed at Danville, Indiana, this 15th day of July, 1912.

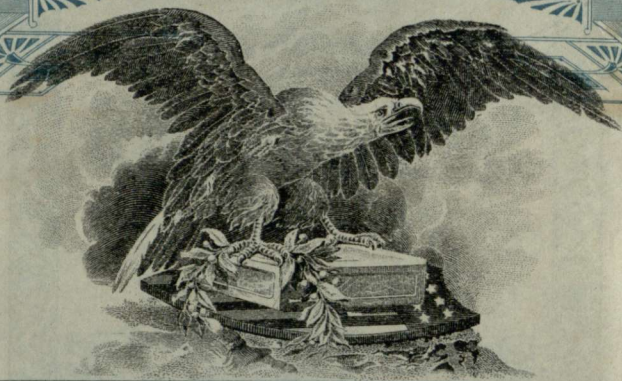

lawful money of the United States of America, with interest at the rate of six per cent per annum, from December 15th, 1930, payable at the same place, on Dec. 15th, 1931, and semi-annually thereafter on the 15th day of June and December of each year until paid, upon presentation of the proper coupons hereto annexed without any relief whatever from valuation or appraisement laws of the State of Indiana. The principal of this bond shall be due and payable at the option of the holder on non payment after due presentation of any of said coupons for ninety days after maturity thereof.

This bond is one of ten (10) of like date, and are numbered from one (1) to (10), both inclusive, consisting of nine (9) bonds of the denomination of \$194.00 each, and one (1) bond of the denomination of \$190.78, amounting in the aggregate to \$1,936.78, issued by the County of Hendricks, Indiana, for the purpose of raising the money necessary to pay the cost of the cleaning, improvement and repair of the R. E. Kennedy drain in Union Township, petitioned for by Carl Eads et al., established by the Hendricks Circuit Court, being cause number 12,852, all of said bonds being issued under and pursuant to the provisions of an Act of the General Assembly of the State of Indiana, entitled "An act concerning drainage and repealing laws in conflict," approved March 11th, 1907, and of the various amendments thereto, and issued under and pursuant to an order made by the full Board of County Commissioners of Hendricks County, Indiana, at a regular session of said Board at the Court House in the town of Danville, Indiana, in said County and State.

And the said County of Hendricks hereby irrevocably pledges to the holder of this bond and each of this series of bonds the credit and good faith of said County for the complete fulfillment of each and every stipulation thereof and the coupons thereto attached and that in issuing the same, all the conditions prescribed by the law of the State of Indiana, under which the same are issued have been complied with and Charles E. Shields, the Auditor and Merritt A. Gregory, John E. Vestal, and Robert E. Parker, the Commissioners of Hendricks County, in the State of Indiana, are hereby authorized to sign all coupons in lithograph.


